"bank qualified". Please include a statement in your reply that you understand that this lease/purchase loan is not "bank qualified".

All quotes must be received by email, courier, mail, or hand-delivered no later than 10:00 AM on November 28, 2017 as determined by the email date/time stamp or the physical time of receipt in the Purchasing Manager's Office. Quotes must be valid until the end of February 2018 to allow for the Board of Commissioners to review and take the appropriate action to approve the lease/purchase terms. Submissions should include amortization schedules for the lease/purchase period showing the total principle, interest rate, total interest to be paid and the quarterly repayment schedule. In the body of the email or cover letter, the submission must state that the financial institution will guarantee that the final lease/purchase documents will contain the governmental funding clause and bank qualified statement requested above.
