Agri Civic Center Concession, Office & Storage Flooring Replacement Bid

SCOPE OF WORK

Furnish all materials, equipment and labor necessary for the complete removal and replacement of the existing VCT flooring with a seamless epoxy flooring product for specified locations at the Okeechobee County Agri Civic Center located at 4601 FL-710 E, Okeechobee, FL 34974. (See exhibit A)

Contractor shall install and provide resinous chip style flooring system with the following minimum physical property requirements when tested according to test methods indicated and no added traction additives:

- 1. Adhesion: 400+ concrete fracture per ASTM D 4541.
- 2. Tensile Strength: 2,000-2,200 per ASTM D 638.
- 3. Impact Direct/Reverse: \leq 95 in.-lb per ASTM D 2794.
- 4. Abrasion Resistance: 12-14 maximum weight loss per ASTM D 4060.
- 5. VOC Content: 30.1 as per ASTM D2369
- 6. COF: 0.99 (DRY) 0.39 (WET) as per ANSI A326.3

The contractor shall be responsible for <u>all</u> final measurements for the resinous flooring and integral cove base material and shall provide pricing to include the following:

- Moisture test prior to removal of existing flooring to ensure adhesion of resinous flooring material to existing substrate.
- > Complete removal and disposal of the existing VCT tiles, adhesive and cove base.
- Surface/substrate preparation to include but not be limited to; shot blasting or diamond grinding. Prepare and clean substrates according to resinous flooring manufacturer's written instructions for substrate indicated. Provide clean, dry substrate for resinous flooring application.
- Contractor shall be responsible and provide materials necessary to fill holes and depressions in substrates according to manufacturer's written instructions.
- Prior to installation, contractor shall install a moisture mitigating primer on all surfaces as required by manufacturer specifications.
- > Install seamless flooring chip style resinous flooring system to include an integral 4" cove base throughout.
- > Decorative ¼" chips shall be used. Color shall be determined by County staff.

Work may begin as early as July 8th, 2020 and shall reach substantial completion no later than July 22nd, 2020. The contractor must maintain a safe work environment at all times and ensure that the job site will be clean and safe at the end of each working day.

Please provide itemized pricing as specified below. Base bid shall be determined by using all or portions of the prices as listed below. Be advised that Okeechobee County reserves the right to select all or portions of each segment to best suit the county's needs. Please refer to Exhibit A for aerial of facility and building references.
