NOTES TO BIDDERS:

The City of Aztec is requesting quotes to provide and deliver **Sand for Our Advanced Nutrient Removal Filter** located at our Wastewater Treatment Plant (WWTP).

1. Provide 144,000 pounds of filter sand. The sand provided shall meet the following requirements.

Effective Size: 0.92 – 0.95 mm

Uniformity Coefficient: < 1.5

- 2. Delivery. Shipping of the sand to our WWTP shall be included in your quote. Provide the shipping quote separately in the form below. Delivery of the sand shall be to 900 South Oliver Drive, Aztec NM 87410. The sand shall be shipped predominantly in 4,000 pound super sacks. Some 3,000 pound super sacks will be acceptable if needed to reduce shipping costs. Vender shall provide a 25 hour notice of the delivery data and time. The City of Aztec will unload the super sacks from the delivery trucks the same day they arrive as long as they arrive before noon local time with a 24 hour notice of arrival time. Arrivals after noon may require that the unloading will extend into the next morning. Unloading will cease at 5 PM local time.
- 3. Quality Assurance. The City of Aztec will test conformance of the sand to the specification after delivery of the sand to our WWTP. A minimum of 10 samples will be taken from the delivered sand and tested for the following parameters: percent passing sieve analysis, effective size, uniformity coefficient, specific gravity, and unit weight. If the average value of the results for both effective size and uniformity coefficient fall within the specified values, then the sand will be deemed to meet the specification. If the average value for these parameters does not meet these criteria, then the sand

does not meet the specification and the supplier must come and load and transport the sand back to the point of generation at the supplier's expense.

- 5. The City reserves the right to select any combination of services quotes. Quote amounts do not include tax.
- 6. Quote document includes 4 pages; quote submittal must include pages 1-3 completed. Page 4 is only required if bidder qualifies for Veteran's preference as defined by New Mexico Taxation and Revenue Department.

- 6.
