- Apply second color coat at manufacturer's recommended rate of coverage.
- Standard color striping on basketball court, per N.T.S.A. regulations. Standard colors include: White, Black, Yellow, Blue, Green, & Red). All other colors are custom.
- ARMOR Crack Repair System or approved equal.
