Please find attached an invitation to quote for the mowing contract for Walker County School's six central service facilities & entrance drive for Saddle Ridge Elementary & Middle for 2019-20. The deadline for submitting a quote is March 27 at 2:00 pm. Quotes received incomplete or after 2:00 pm will not be considered. Submit the quote in a sealed envelope to the Walker County Schools, Facilities & Operations Department at 298 Culberson Avenue, LaFayette, GA 30728.

1. This job should be quoted as a per cut price with a minimum of two cuts per month and will be paid only during the months that mowing is needed between April 1, 2019 and March 31, 2020. During the season when properties do not need to be mowed, there will be no payment.
2. Saddle Ridge Elementary & Middle School is broken down into two contracts. This contract only includes the highlighted area of the entrance drive. The school will handle their own contract for the remaining property surrounding the school and parking areas. Please contact the school to quote the remainder of the project at 706-375-1219.
3. We are requesting submittal of a tentative schedule so that we know when to expect your crew at each site. We do understand that the schedule could be affected by the weather on occasion. Some of our facilities are unoccupied and the schedule is needed in order to provide access to these facilities.
4. Maintenance & the old LaFayette High School are on the same property and should be quoted as one property.
5. Maps of each property are attached so there is no question what is included in each property. If you have any questions regarding what areas to mow, please contact Ritchie Mathews, maintenance supervisor, at 423-667-9489.
6. If awarded the contract, please be prepared to submit your certificate of liability, including workers' compensation, insurance (naming Walker County Board of Education as an additionally insured) and a signed contract as soon as possible so that there is no break in mowing service for our facilities. The current contract expires on March 31, 2019, so we will let you know quickly after the submittal date. We will email the contract to you as soon as a decision is made.

The proposed schedule should include a minimum of two mowing services per month at each location. Please attach a proposed schedule (we understand that it is contingent upon the weather). Additional mowing may be needed at the discretion of the Maintenance Supervisor of the Walker County Schools and should be billed on a per mowing basis. Dates of each mowing should be included on all invoices per site. We will notify the awarded contractor of the start up of the mowing service, when to discontinue for the season, and when additional mowing is needed. The approximate start up date will be April 1, 2019. **Please quote this job on a per mowing basis, as this contract will be paid on a per mowing basis per site and NOT a monthly contract price for the full year.** Services may be needed in the spring, but you will be contacted if the need arises. Services will include removal of all debris, tree limbs, and trash, mowing, weed eating, and removal of grass clippings from sidewalks, driveways, parking, etc. There will be no landscaping included in this quote.






