**FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA
COUNTY, FLORIDA AND
B BERRY'S WELL DRILLING, LLC, DBA BERRY'S WELL DRILLING
CONTRACT NO. C24-4031-PW**

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and B Berry's Well Drilling, LLC, dba Berry's Well Drilling ("Contractor"), executed this 12th day of December, 2025, is made a part of the original Agreement dated August 20, 2024, Contract No. C24-4031-PW (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **AMENDMENT.** The parties hereby wish to amend the original agreement to add the following locations, listed in Attachment "A" which is hereby made a part of the agreement. The wells listed will not be a part of the maintenance scope. They will fall under the Special Maintenance Activates of the scope of services. When a well goes down, a quote will be submitted and approved by the Facility Maintenance Department prior to work beginning.
2. The parties wish to add the **ANTI-HUMAN TRAFFICKING AFFIDAVIT**, hereby attached as Attachment "B" and made part of the agreement.
3. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated August 20, 2024 and any amendments thereto, shall remain in full force and effect.
4. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.



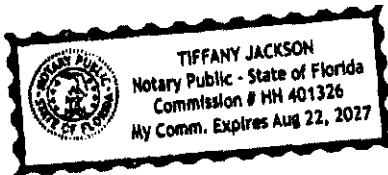
