



TASK ORDER NO. 2 SCOPE OF WORK

1. Engagement and Services

(a) Engagement. Okaloosa County Airports (Destin-Fort Walton Beach Airport-VPS, Bob Sikes Airport-CEW, Destin Executive Airport- DTS hereinafter referred to as the "Airports") engages Volaire Aviation, Inc. (herein referred to as the "Consultant") to provide the services outlined in this section of the Agreement ("Services"). The Consultant accepts the engagement.

(b) Term. This Agreement shall commence on April 1, 2025, and not extend past the master contract terms.

(c) Marketing Scope of Work. The Consultant will collaborate with the Airports on the following marketing projects:

Web Updates: The Consultant will assist in updating the Airports' website(s) to enhance user experience and functionality. This includes implementing any required FAA updates, optimizing site navigation, improving page load speed, enhancing mobile responsiveness, upload requested updates, add new and updated content, features, photos, maps and graphics.

Social Media Management: The Consultant will develop and execute a strategic social media plan for the Airport's Facebook and Instagram channels. This includes a content calendar, creating and scheduling regular posts to engage with the audience, curating relevant content, and analysing performance metrics to optimize content strategy. On demand updates such as airport announcements, news, highlights, warnings and emergency notifications will be implemented as necessary during normal business hours unless previously arranged.

Ad-Hoc Optional Marketing Projects: The Airports may also request additional marketing projects provided the Consultant agrees to perform such work at the time of the request. Items may include but are not limited to:

- Graphic design for advertising;
- Creation and/or redesign of Airport rack cards;
- Production of other social media content;
- Monthly updates on program progress.

The above will be invoiced at a rate of \$250 per hour, with a total not to exceed of \$25,000. Graphic design work will also be invoiced hourly at the rate noted above, as needed, and commissioned by the Airports.

(c) Expenses. Consultant shall be entitled to reimbursement for expenses reasonably incurred in the performance of the Services upon submission and approval of written statements in accordance with the then regular procedures of the Company. Reasonable expenses include but are not limited to, travel (airfare, hotel, rental car, contest platforms, and meals), materials printing, data, and shipping materials. Consultant will invoice all expenses at cost plus a 10% administrative fee. Consultant agrees to comply with any and all expense policies of Okaloosa County Airports.

(d) Payment. The Consultant shall submit to the Company invoices detailing the Services performed, expenses, and the amount due. All such invoices shall be due and payable within thirty (30) calendar days after receipt thereof by the Company.


