# AGREEMENT NO. 23-DHS-EP-161 AMENDMENT NUMBER 2

This Amendment Number 2 is made on the date of execution by the County and amends Agreement Number 23-DHS-EP-161 ("Main Agreement") dated June 29, 2022 between Culpepper Garden III Assisted Living ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. PURSUANT TO PARAGRAPH 4. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM JULY 1, 2024, TO JUNE 30, 2025.

# 2. REPLACE PARAGRAPH 5. CONTRACT AMOUNT IN ITS ENTIRETY WITH THE FOLLOWING:

This is a fixed-price contract. The Contractor agrees that the total payment for the Work in Fiscal Year 2025 (July 1, 2024, through June 30, 2025) will not exceed \$916,469.00, regardless of the number of hours spent in the performance of the Work.

The County will not compensate the Contractor for any goods or services beyond those included in Exhibit A unless those additional goods or services are covered by a fully executed amendment to this Contract.

#### **REVISED EXHIBIT B**

#### **CONTRACT PRICING – FY 2025**

The County agrees to pay to the Contractor an annual amount not to exceed \$916,469, of which:

**The County will pay the Contractor \$861,469** to be distributed in eleven (11) monthly payments of **\$71,789** and one (1) monthly payment of **\$71,790** for basic assisted living care of low- income residents.

The County will pay <u>an annual amount not to exceed \$55,000</u> for the purpose of partially subsidizing the meal program for Culpepper Garden I residents who are SSI (Supplemental Security Income) eligible/qualified or whose income is between SSI and the Federal Poverty Level. The monthly amount invoiced may vary based on the total number of meals each resident records each month. The annual amount may be adjusted based on the residents enrolled in the subsidy program. The subsidy will equal 50% of the monthly cost for residents who are SSI and, if funds are available, 25% of the monthly cost for those eligible residents who are between SSI and Poverty Level. For each resident served by these subsidies the Contractor will submit a completed UAI (Uniform Assessment Instrument) and a Nutrition Screen when the service begins. These documents must be updated and submitted annually. The Contractor must submit a monthly invoice for the number of meals provided including data regarding number of persons served and number of meals served to the residents of Culpepper Garden I and Culpepper Garden II with this subsidy.
