



**EIGHTH AMENDMENT TO THE AGREEMENT
BETWEEN OKALOOSA COUNTY, FLORIDA
AND THE HILLER COMPANIES, LLC
CONTRACT NO. C23-3366-FM**

This Eighth Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and The Hiller Companies, LLC (the "Contractor"), executed this 6th day of May, 2025, is made a part of the original Agreement dated July 20, 2023, Contract No. C23-3366-FM (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **AMENDED PROVISION.** The County and the Contractor wish to amend Section 4 of the original Agreement to add the following locations.

Okaloosa County Jail, 1200 James Lee Blvd E., Crestview, FL 32539

- Clean Agent Inspection= Annual Fee \$620.00 (quantity 1)
- Clean Agent Inspection = Semi-Annual Fee \$620.00 (quantity 1)

TDD Headquarters, 198 Eglin Parkway NE, Fort Walton Beach, FL 32548

- Annual Fire Alarm Inspection = \$1,536.00 (quantity 1)
- Annual Fire Alarm Monitoring Fee - \$450.00 (quantity 1)
- Fire Extinguisher Inspections = \$8.00 ea x 8
8 - 5lb ABCs

2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated July 20, 2023 and any amendments thereto, shall remain in full force and effect.

3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
