Fiber Task Order 10

This Fiber Task Order is issued pursuant to the Agreement for Exclusive Use of Optical Fiber dated December 6th, 2022, between Okaloosa County, Florida (PROVIDER) and LiveOak Fiber, LLC, (CUSTOMER) which is incorporated herein by this reference, with respect to:

Scope of Services
For
Okaloosa County Information Technology Exclusive Use of Optical Fiber

PURPOSE: The purpose of this Fiber Task Order is to define the base cost model and scope of services. The cost model will remain in effect unless modified in future Fiber Orders. It includes IRU related NRC and YRC cost models, as well as head end costs per year.

FIBER ORDER/IRU TERM: 10 years to align with Fiber Task Order 1

DUE DATE: 03/01/2024, unless modified, upon agreement by both parties

COST MODEL: Refer to Fiber Task Order 1

1. Non-recurring IRU Costs (NRC):
 - 1.1. \$1,000 per strand mile. Example, $\$1,200 * 25.00 \text{ miles} = \$1,000 * 12 * 25 = \$300,000$ one-time, NRC.
 - 1.2. 50% at execution of fiber task and remainder dues upon Acceptance.
2. Yearly Recurring Costs/Maintenance (YRC):
 - 2.1. \$1,200 per route mile. Example $\$1,200 * 25.00 \text{ miles} = \$30,000$ annually, YRC.
 - 2.2. 1st year maintenance, due at acceptance. 1st year will be prorated from acceptance date to 08/21/2024 and then due on 08/21 yearly to coincide with Fiber Task Order 1.
3. Splicing/ Meet-me Demarcation Costs: Provider will construct and provision to Customer up to a 48 count SM Fiber Optic Cable (FOC) in a 2" HDPE or another suitable conduit to Customer provided and installed handhole, pull box or other suitable endpoint. This Customer handhole will be the demarcation between the Provider Network and the Customer Network. The specific demarcation will be the entry point of the FOC/conduit at the Customer handhole.
 - 3.1. Fixed (NRC) Cost: \$10,000 for each Meet-me Provider network tie-in location. This includes necessary actions to connect the Meet-me to the Customer network.
 - 3.2. Variable Non-recurring Cost (VNRC): \$25 per Linear Foot (LF) to construct Meet-me tie in between Provider splice enclosure to Customer handhole. Meet-me fiber will be tested, coiled with a minimum of 50 LF of storage, and capped in Customer handhole.
 - 3.3. Additional costs and/or for special conditions if necessary upon agreement by both Parties.
 - 3.4. 50% at execution of Fiber Order and remainder due upon Acceptance.

- 3.5. Additional Maintenance (YRC) based on linear footage to install Meet-me will be prorated and added to yearly fiber maintenance IAW with the Yearly Recurring Cost provisions.

SCOPE OF SERVICES/COMPENSATION PROVISIONS: Provider will provide various segments/strands of county-owned fiber as described below:

4. Non-recurring costs (NRC):

- 4.1. [PB5217 Meet-me]: Meet-me tie-in location in the vicinity of PB5217 at the NW intersection of Valparaiso Pkwy and N Nordberg Ave within 125 LF of PB5217: 125 LF * \$25 = **\$3,125.00 VNRC, \$10,000.00 NRC.**
- 4.2. [PB7000 Meet-me]: Meet-me tie-in location in the vicinity of PB7000 at the intersection of Mary Esther CTO NW and Wright Pkwy NW within 125 LF of PB7000: 125 LF * \$25 = **\$3,125.00 VNRC, \$10,000.00 NRC.**
- 4.3. [PB5026 Meet-me]: Meet-me tie-in location in the vicinity of PB5026 at the North intersection of Miracle Strip Pkwy SE and the East entrance to the Emerald Coast Convention Center within 125 LF of PB5026: 125 LF * \$25 = **\$3,125.00 VNRC, \$10,000.00 NRC.**
- 4.4. [PB5128 Meet-me]: Meet-me tie-in location in the vicinity of PB5128 at the NW intersection of US Hwy 98 and Gulf Shore Dr within 125 LF of PB5128: 125 LF * \$25 = **\$3,125.00 VNRC, \$10,000.00 NRC.**
- 4.5. [PB5208 Meet-me]: Meet-me tie-in location in the vicinity of PB5208 at the NW intersection of US Hwy 98 and Mid Bay Bridge Rd within 125 LF of PB5208: 125 LF * \$25 = **\$3,125.00 VNRC, \$10,000.00 NRC.**
- 4.6. **Subtotal VNRC: \$15,625.00.**
- 4.7. **Total NRC: \$50,000.00 (NRC) + \$15,625.00 (VNRC) = \$62,625.00.**

5. Yearly-recurring costs (YRC):

- 5.1. [PB5217 Meet-me]: \$1,200 * .024 miles = **\$28.80**
- 5.2. [PB7000 Meet-me]: \$1,200 * .024 miles = **\$28.80**
- 5.3. [PB5026 Meet-me]: \$1,200 * .024 miles = **\$28.80**
- 5.4. [PB5128 Meet-me]: \$1,200 * .024 miles = **\$28.80**
- 5.5. [PB5208 Meet-me]: \$1,200 * .024 miles = **\$28.80**
- 5.6. **Total YRC: \$144.00 (1st year contingent on prorated amount).**

As compensation for providing the services under this Fiber Task Order, the CUSTOMER shall pay the PROVIDER in accordance with the December 6th, 2022 agreement for the actual work completed and accepted by the CUSTOMER.
