The line item pricing breakdown from Attachment C: Bid Form should be viewed as the maximum price an agency will be charged under the agreement. Garland/DBS, Inc. administered an informal competitive process for obtaining quotes for the project with the hopes of providing a lower market-adjusted price whenever possible.

## Scope of Work:

- 1. Remove and replace 1 existing HDPE pipe.
- 2. Remove and replace 30 If of gutter with new shop formed 24 gauge standard Kynar finish gutter and gutter support brackets.
- Remove and replace 50 If of downspouts with new shop formed 24 gauge standard Kynar finish downspouts and supports.
- 4. Reattach 4 detached downspouts to gutter.
- 5. Reattach 1 PVC pipe.
- 6. Re feed 2 downspouts into HDPE pipe.
- 7. Seal holes in wall panels with Tuff Stuff MS sealant.
