
This Supplemental Agreement is entered into pursuant to the provision of the original contract.

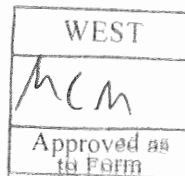
