ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 21-DES-RFP-217 AMENDMENT NUMBER 3

This Amendment Number 3 is made on the date of execution by the County and amends Agreement Number 21-DES-RFP-217 ("Main Agreement") dated August 16, 2021, between Lyft Bikes and Scooters, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. Paragraph 6. <u>CONTRACT PRICE ADJUSTMENTS</u> is **DELETED** in its entirety and **REPLACED** with the following:

6. CONTRACT PRICE ADJUSTMENTS

The Contract Amount/unit price(s) will remain firm until June 30, 2023 ("Price Adjustment Date") and will be adjusted as set forth in Sections 2 and 3 of this Amendment Number 3. To request a further price adjustment, the Contractor must submit a written request to the County not less than 90 days before the next Price Adjustment Date. The next Price Adjustment Date is July 1, 2025. Adjustments to the Contract Amount/unit price(s) will not exceed 2% annually available at the time of the Contract's renewal.

Any Contract Amount/unit price(s) that result from this provision will become effective the day after the Price Adjustment Date and will be binding for 12 months. The new Price Adjustment Date will be 12 months after the price adjustment.

If the Contractor and the County have not agreed on a requested adjustment by 30 days before the Price Adjustment Date, the County may not renew the Contract, whether or not the County has previously elected to renew the Contract's term.

2. The following fees under Exhibit B Contract Pricing, are hereby retroactively increased by 2%. Effective January 1, 2024, the new fee amounts are as follows:
