AGREEMENT NO. 22-DHS-EP-23**

**AMENDMENT NUMBER 1
ASSIGNMENT OF AGREEMENT**

This Amendment Number 1 (“Amendment”) is made on 6/8/2022 by the County and amends Agreement Number 22-DHS-EP-23 (“Main Agreement”) between Volunteers of America, Inc., 1660 Duke Street, Alexandria, VA 22314 (“Contractor”), and the County Board of Arlington County, Virginia (“County”).

Volunteers of America, Inc. and the County entered into the Main Agreement for Volunteers of America, Inc. to provide Developmental Disabilities Residential Services.

Volunteers of America Chesapeake, Inc. has assumed all of Volunteers of America, Inc. rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Volunteers of America Chesapeake, Inc. beginning on 6/8/2022 (“Effective Date”).

The Main Agreement is therefore amended as follows:

1. Volunteers of America, Inc. is in all instances replaced with Volunteers of America Chesapeake, Inc.;
2. The term “Contractor” in the Main Agreement means Volunteers of America Chesapeake, Inc.;
