## AGREEMENT NO. 23-DES-RFP-230I AMENDMENT NUMBER 1

This **Amendment Number 1** is made on the date of execution by the County and amends **Agreement Number 23-DES-RFP-230I** ("Main Agreement") dated July 17, 2023, between **The Cadmus Group LLC** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. PURSUANT TO PARAGRAPH 4. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM JULY 1, 2024 TO JUNE 30, 2025.
- 2. PARAGRAPH 6. CONTRACT PRICE ADJUSTMENTS IS HEREBY DELETED IN ITS ENTIRETY AND REPLACED WITH THE FOLLOWING:

#### 6. CONTRACT PRICE ADJUSTMENTS

The Contract hourly rate(s) will remain firm until June 30, 2024 ("Price Adjustment Date"). To request a rate adjustment, the Contractor or the County must submit a written request to the other party not less than 90 days before the Price Adjustment Date. Adjustments to the Contract hourly rate(s) will not exceed 3%.

Any Contract hourly rate(s) that result from this provision will become effective the day after the Price Adjustment Date and will be binding for 12 months. The new Price Adjustment Date will be 12 months after the price adjustment.

If the Contractor and the County have not agreed on a requested adjustment by 30 days before the Price Adjustment Date, the County may not renew the Contract, whether or not the County has previously elected to renew the Contract's term.
