The County and Contractor hereby agree as follows:

1. The County would like to amend the original agreement for interior and exterior services for general pests only as follows:

Add the following locations to the service agreement, effective upon execution:

Okaloosa Island Welcome Center, 1540 Miracle Strip Pkwy SE	\$29.00 monthly
Crestview Welcome Center, 5131 S Ferdon Blvd	\$35.00 monthly
Shoal River Lodge, 5929 Broken D Ln	\$57.00 quarterly

Add the following locations to the service agreement, effective October 1, 2024:

Fairgrounds, 1958 Lewis Turner Blvd	\$495.00 quarterly
Baker Arena, 5503 FL-4	\$285.00 quarterly

2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated December 21, 2020 and any amendments thereto, shall remain in full force and effect.
3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
