CONTRACT AMENDMENT/MODIFICATION NO. ONE (0001)

This Amendment/Modification Number One (0001) ("Amendment/Modification") is made on the date of execution of the Amendment by the County and amends Contract Number 17-2 ("Main Agreement, as amended or "Contract) between RGA, LLC, a Virginia Limited Liability Company, located at 1550 Standing Ridge Drive, Powhatan, Virginia ("Contractor"), and the County Board of Arlington County, Virginia ("County").

WHEREAS, RGA, LLC and the County entered into the Main Agreement to provide traffic equipment to Arlington County to maintain, repair and re-build the traffic signal system;

WHEREAS, RGA, LLC has transferred all the terms, conditions, and Scope of Work as contained in the Contract to Mobotrex, Inc., an Iowa Corporation, pursuant to the General Assignment and Assumption Agreement ("Assignment Agreement"); and

WHEREAS, under the Assignment Agreement Mobotrex, Inc., has assumed all obligations and liabilities of RGA, LLC under this Contract by virtue of the above transfer; and

WHEREAS, the County consents to the assignment of this Contract to Mobotrex, Inc., commencing on the date of execution of this Amendment/Modification ("Effective Date"); and

WHEREAS, in consideration of the promises and other good and valuable consideration specified in this Amendment Modification Main Agreement is amended as follows:

1. In place of RGA, LLC Arlington County agrees that Mobotrex, Inc., shall be the contracting party, and Mobotrex, Inc., shall provide the services under the Contract;
2. RGA, LLC confirms this transfer and waives any claims and rights against Arlington County that it now has or may have in the future in connection with this Contract; and

Mobotrex, Inc., agrees to be bound by and to perform this Contract in accordance with the terms and conditions contained in the Contract Documents; and

3. The term "Contractor" in the Contract shall hereinafter mean Mobotrex, Inc.

NOW THEREFORE,

All other terms and conditions of the Main Agreement shall remain in full force and effect.
