WHEREAS, it is to the mutual advantage and benefit to the parties hereto that each of the parties effectively assist the other in the event of a communication failure or other occurrence causing the need to vacate or relocate from the primary communication center facility.

- 1. That the parties will set forth the necessary policies and procedures to provide proper notification to the agencies they provide service for on how emergency dispatch operations will occur.
- 2. That the Ocean City Wright Fire District will provide, if possible, temporary personnel to assist with the receipt and dispatch of emergency calls until the County Warning Point personnel can relocate.
- 3. That the parties will facilitate the dispatch and receipt of jurisdictional emergency calls utilizing Ocean City Wright Fire Department's facility, radio, frequency, telephone or fax systems.
- 4. No party to this agreement shall be required to pay any compensation to any other party to this agreement for services rendered as the mutual advantages and protection afforded by this agreement being considered adequate compensation to all of the parties.
- 6. Any services performed or expenditures made in connection with furnishing mutual aid under this agreement by either party hereto shall be deemed conclusively to be for the direct protection of such party.

7. Any party to this agreement may withdraw at any time, upon thirty days written notice to each of the parties, and thereafter, such withdrawing party shall no longer be party to this agreement
