AMENDMENT NUMBER 3

This Amendment Number 3 is made on the date of execution by the County and amends Agreement Number 22-DES-ITBLW-410-C ("Main Agreement") dated December 16, 2021 between R. E. Lee Electric Company, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:


- 1. PURSUANT TO CONTRACT CLAUSE 6. CONTRACT PRICE ADJUSTMENTS, THE CONTRACT AMOUNT IS HEREBY INCREASED BY A 3% (NEGOTIATED), FOR THE 12 MONTH PERIOD ENDING DECEMBER 31, 2024.**
- 2. REPLACE EXHIBIT B. CONTRACT PRICING, IN ITS ENTIRETY WITH THE ATTACHED.**
- 3. PURSUANT TO CLAUSE 4. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM JANUARY 1, 2024 TO DECEMBER 31, 2024.**

All other terms and conditions of the Main Agreement remain in effect.


