**AGREEMENT NO. 18-092-R
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on December 10, 2021 and amends Agreement Number 18-092-R (“Main Agreement”) dated January 11, 2019 between Carousel Industries, Inc. (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the Main Agreement as follows:

1. **EXTEND THE CONTRACT TERM TO NOVEMBER 27, 2022 IN ACCORDANCE WITH THE ATTACHED VITA CONTRACT NUMBER VA-161128-CRSL MODIFICATION NO. 2.**
2. **REPLACE THE CONTACT INFORMATION FOR ARLINGTON COUNTY PUBLIC SAFETY COMMUNICATIONS AND EMERGENCY MANAGEMENT SECTION OF CLAUSE 18. NOTICES, IN ITS ENTIRETY AS FOLLOWS:**

3. **ADD THE FOLLOWING COVID-19 VACCINATION POLICY FOR CONTRACTORS CLAUSE AS CONTRACT CLAUSE 21:**

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County’s workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, should be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

All other terms and conditions of the Main Agreement remain in effect.

This Modification No. 2 ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**"), and Carousel Industries Inc ("**Supplier**"), to modify and amend Contract No. VA-161128-CRSL ("**Contract**").
