A RESOLUTION ACCEPTING THE PROPOSAL OF CMG PRO SECURITY, INC., TO PROVIDE UNIFORMED SECURITY **GUARD** SERVICES **FOR EVENTS** AT **PEABODY** AUDITORIUM. THE **MUNICIPAL** STADIUM. BANDSHELL, AND OTHER CITY FACILITIES, FOR AN ANNUAL AMOUNT NOT TO EXCEED \$44,000 FOR A ONE-YEAR TERM WITH FOUR ONE-YEAR RENEWAL OPTIONS: AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE GENERAL SERVICERS TERM CONTRACT NO. 0117-3540; AUTHORIZING THE CITY MANAGER TO EXERCISE THE RENEWAL OPTIONS SUBJECT BUDGETING AND APPROPRIATIONS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City issued a Request for Uniformed Security Guard Services for events at Peabody Auditorium, the Municipal Stadium, the Bandshell, and other City facilities; and

WHEREAS, the City Manager or his designee has reviewed proposals submitted for the services; and

WHEREAS, the Cultural Services and Community Events Director recommends acceptance of the proposal submitted by CMG Pro Security, Inc., for the guard services for an annual amount not to exceed \$44,000, for a one-year term with four one-year renewal options, and that the City Manager be authorized to exercise the renewal options: and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The proposal submitted by CMG Pro Security, Inc., to provide

Uniformed Security Guard Services for certain events at Peabody Auditorium, the Municipal

Stadium, the Bandshell, and other City facilities, for an annual amount not to exceed \$44,000 for a

one-year term with four one-year renewal options, is hereby accepted.

SECTION 2. The Mayor and City Clerk are hereby authorized to execute General

Services Term Contract No. 0117-3540 with CMG Pro Security, Inc. A copy of the Contract in

substantially final form is attached hereto and by reference made a part hereof.

SECTION 4. The City Manager is hereby authorized to exercise the renewal

options subject to budgeting and appropriation.

SECTION 5. This Resolution shall take effect immediately upon its adoption.
