

FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA
COUNTY, FLORIDA AND LITTLE TIRE HAULING, INC.
CONTRACT NO. C22-3229-PW

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and Little Tire Hauling, Inc. (the "Contractor"), executed this 20th day of March, 2024, is made a part of the original Agreement dated September 7, 2022, Contract No. C22-3229-PW (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. The County and Contractor wish to amend Section 4 of the original Agreement to adjust the rate for Tire Waste Removal Services (pricing shall be for all sizes including with or without rims, per pick up, per delivery, per container of any size) from \$550.00 flat fee to \$750.00 and retroactively take effect March 8 2024.
2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated September 7, 2022, and any amendments thereto, shall remain in full force and effect.
3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.

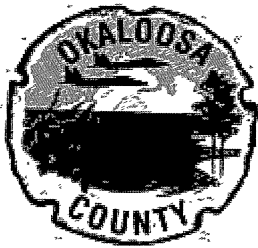
