

The county currently leases the Second Beach Boat Basin to the Okaloosa Island Leaseholders Association on a yearly basis with renewal occurring each July.

This past year the OILA Boat Basin Committee made a financial commitment of \$10,019,17 for major repairs, i.e. installation of new decking, new walkways, electrical upgrading and silt fencing. We would like to see this capital outlay protected and request that the annual lease now in effect be extended to a five-year lease.

It is felt that the extended lease period would encourage greater contribution of time and equity if the membership could be assured of continuing access to the basin after making such investments.
