#### **AMENDMENT NUMBER 3**

This Amendment Number 3 ("Amendment") is made on the date of execution of this Amendment by the County and amends Arlington County Agreement Number 713-13-1, dated <u>February 1, 2016</u> ("Main Agreement as Amended"), and made between Jacobs Project Management Co. of 1100 North Glebe Road, Suite 500, Arlington, VA 22201 ("Contractor"), a Delaware corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term under the Main Agreement, as Amended, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

#### I. Section 6 ("Contract Term") of the Main Agreement shall be amended as follows:

The Work shall commence upon execution of this Agreement by the County and shall continue until <u>December 31, 2017</u> ("Subsequent Contract Term"), subject to any modification as provided for in the Contract documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of an amendment executed by the parties, authorize continued operations of the Contractor under the same contract unit prices for not more than <u>three (3)</u> additional <u>twelve (12)</u> month periods (from <u>January 1, 2018</u> to <u>December 31, 2020</u>. Each such period shall be referred to as "Subsequent Contract Term").

All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.
