

RESOLUTION NO. 19-345

A RESOLUTION APPROVING THE WRITTEN AGREEMENT WITH CONNECT CONSULTING, INC., FOR PROFESSIONAL HYDROGEOLOGICAL SERVICES AT BRENNAN WATER TREATMENT PLANT FOR A TERM ENDING APRIL 26, 2020; AUTHORIZING THE CITY MANAGER TO APPROVE AN EXPENDITURE OF UP TO \$60,000 FOR AS-NEEDED HYDROGEOLOGICAL SERVICES FOR FISCAL YEAR 2020 WITH THE OPTION TO RENEW UP TO ONE-YEAR AND EXPEND SUCH SUMS AS BUDGETED IN FISCAL YEAR 2021; AUTHORIZING THE WRITTEN AGREEMENT, PIGGYBACKING A SEMINOLE COUNTY CONTRACT; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE AGREEMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 30-54(b), City Code, authorizes the City to procure goods and services without the necessity of competitive selection pursuant to a piggyback contract; and

WHEREAS, the Brennan Water Treatment Plant (WTP) has 26 groundwater wells that supply raw water to the plant for treatment to drinking water standards; and

WHEREAS, professional services for condition assessment and repair of the wells' drop pipes, pumps, and electrical motors are needed, and piggybacking from the Seminole County is the most efficient way to access these services; and

WHEREAS, the written agreement has been prepared, piggybacking the Seminole County Contract, for as-needed hydrogeological services throughout the City limits for a term ending April 26, 2020; and

WHEREAS, the Utilities Director recommends approval of the written agreement and requests authorization to expend up to \$60,000 during the remainder of fiscal year 2020; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The written agreement for as-needed hydrogeological services throughout the City limits for a term ending April 26, 2020, with a one-year renewal as further described in the recitals, is hereby approved.


SECTION 2. The Mayor and City Clerk are hereby authorized to execute the Agreement referenced above. A copy of the Agreement in substantially final form is attached hereto and made a part hereof by reference.

SECTION 3. The expenditure of funds in the amount of \$60,000 for fiscal year 2020, is hereby approved.

SECTION 4. The City Manager is authorized to renew the above-referenced Agreement on the City's behalf for fiscal year 2021 and expand such sums subject to budgeting and appropriation.

SECTION 5. It is found that the agreements provided for in Section 1 above is made pursuant to Section 30-54, City Code, and is in the best interest of the City.

SECTION 6. This Resolution shall take effect immediately upon its adoption.
