AMENDMENT NUMBER 1
ASSIGNMENT OF AGREEMENT**

This Amendment Number 1 ("Amendment") is made on the date of execution by the County and amends Agreement Number 19-240-ITB ("Main Agreement") between Vision Technologies, Inc., 530 McCormick Drive, Suite G, Glen Burnie, MD 21061 ("Contractor"), and the County Board of Arlington County, Virginia ("County").

Vision Technologies, Inc., and the County entered into the Main Agreement for Vision Technologies, Inc. to provide Telecom Services & Cabling.

Hitt Holding Corporation dba Vision Technologies, LLC has assumed all of Vision Technologies, Inc. rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Hitt Holding Corporation dba Vision Technologies, LLC beginning on the date of execution of this agreement ("Effective Date").

The Main Agreement is therefore amended as follows:

1. Vision Technologies, Inc. is in all instances replaced with Hitt Holding Corporation dba Vision Technologies, LLC;
2. The term "Contractor" in the Main Agreement means Hitt Holding Corporation dba Vision Technologies, LLC;
