AGREEMENT NO. 16-328-ITB

AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on the date of execution by the County and amends Arlington County Agreement Number 16-328-ITB, dated June 29, 2016, ("Agreement") and made between Apple Valley Glass & Door, Inc., P.O. Box 1096, 2476 Nestle Quarry Road, Falling Waters, WV 25419 ("Contractor"), a corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term of the Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Agreement as follows:

I. Section 3 ("Contract Term") of the Agreement shall be replaced with the following:

CONTRACT TERM

The Work shall commence on the date of the execution of the Agreement by the County, and shall be completed no later than June 30, 2018 ("Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of an amendment executed by the parties, authorize continued operations of the Contractor under the same contract prices for not more than three (3) additional twelve (12) month periods from July 1, 2018 to June 30, 2021 (each such period shall be referred to as "Subsequent Contract Term").

All other terms and conditions of the Agreement shall remain in full force and effect.
