

**FIRST AMENDMENT
TO
JOINT PARTICIPATION AGREEMENT
BETWEEN
THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION
AND
THE COUNTY OF SANTA ROSA, FLORIDA**

This Amendment is between the State of Florida, Department of Transportation, "Department," whose mailing address is, 1074 Highway 90, Chipley, Florida 32428 and the County of Santa Rosa, "County".

WITNESSETH

WHEREAS, the Department and the County entered into an Agreement, Contract No. **ASE99**, on August 21, 2019, for landscaping of SR 10 (US 90) from west of Escambia River to CR 197A under Financial Project No. 443824-1-58-01 ("Project"); and

WHEREAS, the parties desire to amend the Agreement to provide additional funding in the amount of two hundred thousand and 00/100 dollars (\$200,000.00) for the Project, to extend the term for the Installation Phase, and to increase the limits of the Project, as set forth below.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. The recitals in the Whereas clauses above are incorporated into this Amendment.
2. Section 9 (Reimbursement and Payment), paragraph A, subparagraph i), of the Agreement is hereby amended by deleting the amount "TWO HUNDRED AND FIFTY THOUSAND and 00/100 DOLLARS (\$250,000.00)", wherever appearing therein, and substituting the amount "FOUR HUNDRED AND FIFTY THOUSAND and 00/100 DOLLARS (\$450,000.00)", in lieu thereof.
3. Exhibit "B" (Method of Compensation) of the Agreement is hereby amended by deleting the amount "TWO HUNDRED AND FIFTY THOUSAND and 00/100 DOLLARS (\$250,000.00)", wherever appearing therein, and substituting the amount "FOUR HUNDRED AND FIFTY THOUSAND and 00/100 DOLLARS (\$450,000.00)", in lieu thereof.

4. Section 8 (Term), paragraph A, subparagraph i), of the Agreement is hereby amended by deleting the date "September 30, 2020", wherever appearing therein, and substituting the date "December 31, 2022", in lieu thereof.
5. The limits of the Project are amended to be as follows:

SR 10 (US 90) from west of Escambia River at Bass Hole Cove (MP 2.151) to CR 197A/Bell Lane/School Lane (MP 7.073)
6. Except as modified in this Amendment, the provisions, terms and conditions of the Agreement shall remain in full force and effect.





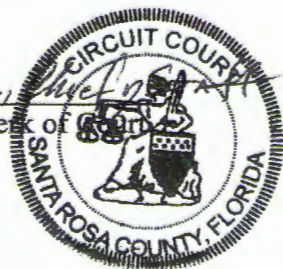
