AMENDMENT NO. 2 TO
COOPERATIVE (PIGGYBACK) PURCHASE AGREEMENT BETWEEN
OKALOOSA COUNTY, FLORIDA AND GODFREY ENVIRONMENTAL CONTRACTS, LLC
NO. FWB21-005
(COUNTY CONTRACT # C21-3069-TDD)

This AMENDMENT NO. 2 hereby amends the Cooperative (Piggyback) Purchase Agreement for the Okaloosa County Tourist Development Department ("Contract"), by and between Okaloosa County, Florida ("County") and Godfrey Environmental Contracts, LLC ("Contractor"), effective April 13, 2021.

WHEREAS, the original term was for twenty-six (26) weeks, and the Contract provides for four (4) one (1) year renewals; and

WHEREAS, both parties exercised a partial renewal through December 31, 2021; and

WHEREAS, both parties desire to renew the remaining balance of the first-year renewal through October 12, 2022.

NOW THEREFORE, in consideration of the mutual covenants herein and other good and valuable consideration, the parties hereby agree to amend County Contract # C21-3069-TDD as follows:

1. Contract # C21-3069-TDD shall be renewed retroactively from January 1, 2022 through October 12, 2022.
2. This AMENDMENT NO. 2 shall be effective upon execution of the County.
3. All other provisions of the County Contract # C21-3069-TDD shall remain in full force and effect.
