**AGREEMENT NO. 514-12
AMENDMENT NUMBER 8**

This Amendment Number 7 is made on the date of execution by the County and amends Agreement Number 514-12 dated June 20, 2011, ("Main Agreement") and Amendments 1-7, between **Community Living Alternatives Corporation, 9401 Lee Highway #406, Fairfax, VA 22031** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Contract Term and Exhibit B (Contract Rates) as follows:

REVISE SECTION 3 ("CONTRACT TER") OF THE MAIN AGREEMENT AS FOLLOWS:

3. CONTRACT TERM

The Work shall continue from **July 1, 2019** and be completed no later than **June 30, 2020** (Subsequent Contract Term) subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor for not more than one (1) additional twelve (12) month periods from **July 1, 2020 to June 30, 2021** (Each such period shall be referred to as a "Subsequent Contract Term"). The Contract Amount and the hourly rate for each Subsequent Contract Term shall be in an amount mutually agreed upon but which will in no event exceed the funds appropriated for the service by the County Board of Arlington County. The total Contract amount may be increased or decreased during the remaining Contract Terms if available funds exceed or, in the alternative, are not sufficient to maintain then current service levels.



AMENDED EXHIBIT B

CONTRACT RATES

The County shall pay the Contractor a **total not to exceed \$203,988.96** in FY 2020.

The County shall pay the Contractor **\$262.28 per day** for each of the two (2) Arlington individuals in the Supervised Living Setting, up to a maximum of 732 Bed Days, up to a **maximum of \$191,988.96** per year.

The County shall also pay an additional \$500 per month per resident for housing assistance, not to exceed a **maximum of \$12,000 total**.

Clients shall not pay more than 30% of their income on housing and this shall be reflected in their residential fee agreement. The current residential fee agreement shall be received by Arlington County ID services for the Contractor to bill for rental assistance.

The County will reduce the monthly payment for discharged or attrition County clients at the rate of \$262.28 per day per resident and \$500 per resident per month.

Arlington County funds shall be used in adherence to all Federal and Commonwealth of Virginia regulations governing residential programs that are licensed by DBHDS.
