This Modification No. 2 ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**"), and Daly Computers, Inc. ("**Supplier**"), to modify and amend Contract No. VA-180917-DALY ("**Contract**") in accordance with the terms and conditions of this Modification. The foregoing is the complete and final expression of the agreement between Supplier and VITA to modify the Contract and cannot be modified, except by writing signed by duly authorized representatives of both parties.
