**AGREEMENT NO. 20-237-ITB-3
AMENDMENT NUMBER 2**

This Amendment Number **2** is made on 11/8/2022 by the County and amends Agreement Number **20-237-ITB-1** ("Main Agreement") dated **October 23, 2020**, between **Metron-Farnier, LLC** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. **PURSUANT TO SECTION 4. CONTRACT TERM:** THE CONTRACT IS HEREBY RENEWED FROM **OCTOBER 23, 2022, TO OCTOBER 22, 2023. TWO (2) ONE-YEAR RENEWALS REMAIN.**
2. **PURSUANT TO SECTION 6. OPTIONAL PRICE ADJUSTMENTS:** Adjustments to the Contract Amount/unit price(s) will not exceed the percentage of change in the U.S. Department of Labor Consumer Price Index, All Items, Unadjusted, Urban Areas ("CPI-U") for the 12-month period preceding the Price Adjustment date of each year of the Contract. Any Contract Amount/unit price(s) that result from this provision will become effective the day after the Price Adjustment Date and will be binding for 12 months.
