

- Time for original service call SV2211290111 included in this proposal.
- Lock out and tag out chiller per the Daikin safety protocol.
- Recover refrigerant from circuits 1 and 2 per the epa regulations.
- Swapped EXV motors from circuit 1 to circuit 2 and recharged circuit 2 to try and get running but the valve still would not open.
- Supplied and installed new EXV, EXV module and liquid level sensor on circuit 1.
- Also installed new filter driers, oil filter and discharge sensor.
- Provided and installed new EXV and EXV module on circuit 2.
- Pressure tested system with nitrogen and evacuated to 500 microns.
- Charged both systems with recovered refrigerant.
- Removed frog from behind circuit 2 EXV module shorting it to ground.
- Started both circuits and monitored operation, all ok at this time.

- Vibration analysis testing is not included
- · Refrigerant is not included
- Compressor overhaul/internal inspection is excluded
