THIS TASK ORDER IS ISSUED PURSUANT TO THE AGREEMENT FOR CONSULTING SERVICES DATED SEPTEMBER 2022, BETWEEN THE COUNTY OF OKALOOSA COUNTY, FLORIDA AND HDR, WHICH IS INCORPORATED HEREIN BY THIS REFERENCE, WITH RESPECT TO

Scope of Basic Services for Okaloosa County Water and Sewer I-10/PJ Adams and Crestview Bypass – Record Drawings

Article A. Purpose:

The purpose of this Task Order is to authorize and direct HDR ENGINEERING, INC. (CONSULTANT) to proceed with professional engineering services for providing professional engineering design services to the Okaloosa County Water and Sewer Department (CLIENT). The activities that are included are described in "Article B - Scope of Services."

Article B. Scope of Services:

The CONSULTANT agrees to furnish professional engineering services that are applicable to the I-10/PJ Adams and Crestview Bypass Record Drawings (Project), as requested by the CLIENT's representative.
