AGREEMENT NO. 18-136-R
AMENDMENT NUMBER 01

This Amendment Number 01 is made on April 9, 2021 and amends Agreement Number 18-136-R (“Main Agreement”) dated December 19, 2017 between School Health Corporation (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. EXERCISE THE FINAL SUBSEQUENT CONTRACT TERM UNDER PARAGRAPH 2 IN ACCORDANCE WITH SOURCEWELL’S LETTER OF AGREEMENT TO EXTEND THE CONTRACT (PROVIDED AS AN ATTACHMENT TO THIS AMENDMENT):

The Contract is hereby renewed for an additional twelve (12) month period starting July 26, 2021 through July 25, 2022, subject to any modification as provided for in the Contract Documents (final Subsequent Contract Term).

2. REPLACE THE FIRST PARAGRAPH OF THE CONTRACT PRICING UNDER PARAGRAPH 3 AS FOLLOWS:

The County will pay the Contractor in accordance with the terms of the Payment paragraph below, using the pricing discounts set forth in the Sourcewell Contract #061417-SHC, which can be found at <https://www.sourcewell-mn.gov/cooperative-purchasing/061417-shc#tab-pricing>, for Work provided by the Contractor, as described and required in the Contract Documents, and accepted by the County.

All other terms and conditions of the Main Agreement remain in effect.
