A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE PROFESSIONAL SERVICES CONTRACTS WITH JAY AMMON ARCHITECT, INC., AND PROFESSIONAL SERVICES, INC., D/B/A INTERTEK PSI, IN ACCORDANCE WITH THE CONSULTANTS' COMPETITIVE NEGOTIATION ACT AND CHAPTER 30, CITY CODE, TO PROVIDE AS-NEEDED ROOFING CONSULTING SERVICES; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City issued a Request for Proposals for Continuing Professional Roofing Consulting services, in accordance with the Consultants' Competitive Negotiation Act ("CCNA"), § 287.055, Florida Statutes, and Chapter 30 of the City Code; and


WHEREAS, proposals were received and reviewed in accordance with the CCNA and Chapter 30, City Code; and

WHEREAS, the Deputy Public Works Director recommends approval of the Continuing Professional Services Contracts with Jay Ammon Architect, Inc., and Professional Services, Inc., d/b/a Intertek PSI, for as-needed roofing consulting services.
