AGREEMENT NO. 21-DPR-ITB-499
AMENDMENT NUMBER 2**

This Amendment Number 2 is made on 10/2/2023 and amends Agreement Number 21-DPR-ITB-499 ("Main Agreement") dated February 15, 2021, between Old Dominion Softball Umpires Association ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

- 1. Contract Renewal:** Pursuant to contract provision 4. Contract Term ([as amended below](#)), this contract is hereby renewed for an additional 12-month period, from January 1, 2024, to December 31, 2024 (Second Subsequent Contract Term) with one (1) additional 12-month period remaining. Notice of Renewal, dated February 14, 2023, for the 12-month period from January 1, 2023, to December 31, 2023, was executed through issuance of a unilateral renewal signed by both parties.
- 2. Delete Exhibit C: Contractor Covid-19 Vaccination Certification from Paragraph 1. Contract Documents.**
- 3. Delete Exhibit C: Contractor Covid-19 Vaccination Quarterly Compliance Certification from Paragraph 1. Contract Documents.**
- 4. Contract Term** is hereby changed to read:

4. CONTRACT TERM

The Work will commence on March 1, 2021, and must be completed no later than December 31, 2022 ("Initial Contract Term"), subject to any modifications provided in the Contract Documents. Upon satisfactory performance by the Contractor the County may, through issuance of a [bilateral Notice of Renewal](#), authorize continuation of the Agreement under the same contract prices for not more than three (3) additional 12-month periods, from January 1, 2023, to December 31, 2025 (each a "Subsequent Contract Term"). The Initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

- 5. Payment Terms is hereby changed to read as follows:**

7. PAYMENT TERMS

The Contractor must submit invoices to the County's Project Officer, who will either approve the invoice or require corrections. The County will pay the Contractor within 45 days after receipt of an invoice for completed work that is reasonable and allocable to the Contract and that has been performed to the satisfaction of the Project Officer. [All payments will be made from the County](#)

to the Contractor via ACH. The number of the County Purchase Order pursuant to which goods or services have been delivered or performed must appear on all invoices.

The Contractor also must submit to the County’s Project Officer its W-9 Form, which will include its Federal Employer Identification Number (“FEIN”) or Social Security Number (“SSN”), whichever is applicable, before the County can process payment to the Contractor under the Contract.

- 6. **Contract provision 55. Covid-19 Vaccination Policy For Contracts is hereby deleted in its entirety.**
- 7. **Exhibit B – Contract Pricing** is hereby replaced with the attached **Revised Exhibit B – Contract Pricing** to change the “Estimated Games per Year” to “**Estimated Games per Season**”.

All other terms and conditions of the Main Agreement remain in effect.
