

ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 22-DES-RFPLW-537 AMENDMENT NUMBER 2

This Amendment Number 2 is made on January 15, 2024, amends Agreement Number 22-DES-RFPLW-537 ("Main Agreement") dated February 23, 2023, between SP Plus Corporation dba SP+ Municipal Services (Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. <u>Contract Renewal</u>: Pursuant to contract clause 4. Contract Term, this contract is renewed for an additional 12-month period, from January 16, 2024, to January 15, 2025, with five (5) additional 12-month renewal periods remaining.
- 2. <u>Contract Price Adjustment</u>: Pursuant to contract clause 6. Contract Price Adjustments, the Contract Amount/unit price(s) adjustment will not exceed the negotiated 3.0% for the 12 months.
