Task Order 05

THIS TASK ORDER IS ISSUED PURSUANT TO THE AGREEMENT FOR CONSULTING SERVICES DATED SEPTEMBER 28, 2022, FOR THE BOARD OF COUNTY COMMISSIONERS OF OKALOOSA COUNTY, FLORIDA, WHICH IS INCORPORATED HEREIN BY THIS REFERENCE, WITH RESPECT TO:

Water System Improvements Facilities Plan Article A.Purpose

Introduction

The Board of County Commissioners of Okaloosa County (the "COUNTY") Water and Sewer Department provides drinking water to residential and commercial customers within the COUNTY's designated water service area. The COUNTY supplies water to the community sourced from multiple groundwater wells spread out across the county. In recent years the COUNTY has experienced multiple water quality issues stemming from some aging wells and groundwater conditions. The COUNTY identified four (4) groundwater wells for replacement or for new construction to increase system capacity and reliability. The COUNTY desires to pursue a State Revolving Fund (SRF) construction loan through the Florida Department of Environmental Protection Agency (FDEP) to finance a five-year Capital Improvements Plan (CIP) to construct these new wells along with a new tank and watermain infrastructure. This Task Order (TO) was requested by the COUNTY for Jacobs Engineering Group Inc. (Jacobs) to prepare a Facilities Planning Document to evaluate the water system improvements in accordance with SRF requirements.

Article B.Scope of Services

Facilities Plan

Jacobs will prepare a comprehensive Facilities Planning Document for the evaluation and recommendation of water system improvements in accordance with SRF planning document guidelines. The planning document will evaluate and compare up to 3 system improvement alternatives and will present the improvements in a phased approach.

The Facilities Plan is assumed to include the rehabilitation or construction of the following water system infrastructure:

- Antioch Well
- Shoal River Ranch Well
- Northgate Well
- Office Well
- New Florosa Tank
- New West County Northern Bypass Watermain
- New East County Supplemental Water Transmission Main
- New Shoal River Tank
- New Longwood/Poquito Area Transmission Main

New Auburn Water Emergency Interconnect

Jacobs will base the replacement well design flows on the existing well capacities in conjunction with input from the COUNTY. Jacobs will evaluate the elevated water storage tank design volumes in conjunction with input from the COUNTY. For the new water system infrastructure Jacobs will use flow projections and or direction provided by the COUNTY. The proposed design capacities will be presented in the Facilities Planning Document as the preliminary design goals. The final well designs will need to be based upon the groundwater and soil characteristics at the actual well site. No site specific or subsurface investigations will be performed in this Task Order.

Jacobs will submit a draft of the Water System Improvements Facilities Plan to the COUNTY for review. Upon receiving review comments from the COUNTY, Jacobs will update the plan and submit a final Water System Improvements Facilities Plan.

Funding Assistance

Jacobs will submit the final facilities plan to FDEP for review and acceptance in the SRF program. Jacobs will coordinate with FDEP as needed through the acceptance process. Jacobs will also prepare and submit one (1) Request for Inclusion (RFI) application for construction funds through SRF and will provide general assistance with the SRF application process (up to 40 hours)

Deliverables

- Water System Improvements Facilities Plan Draft
- Water System Improvements Facilities Plan Final
- Planning Documents submission to FDEP

Assumptions and Specific Conditions

The following assumptions have been taken into consideration in the preparation of this Scope of Services and compensation. Should deviations from these assumptions be required to deliver the services described in this Scope of Services, the scope of work and compensation shall be modified accordingly and approved by COUNTY in writing prior to executing the changes to the Scope of Services.

- It is assumed Jacobs will not be responsible for preparing population or water demand projections for the well designs.
- It is assumed the facilities plan will be conceptual in nature for the purpose of planning and acceptance of a planning document for SRF funding. The document will not include detailed design or detailed drawings.
- It is assumed Jacobs will not be responsible for selecting or evaluating specific land parcels for constructing the wells or tanks or for conducting field investigations for site feasibility.
- Jacobs will reasonably rely upon the accuracy, timeliness, and completeness of information gathered and or provided by governing agencies, the COUNTY and other industry sources.

Article C. Schedule

Work will begin upon execution of this Task Order. A preliminary milestone schedule is shown below.

Compensation will be \$42,310 on lump sum basis. Jacobs will keep the COUNTY informed of progress so that the budget and/or work effort can be adjusted if found necessary.

The fee is based on immediate authorization to proceed.
