AMENDMENT NUMBER 2

CONTRACT TERM


The work shall continue from July 1, 2019 through **June 30, 2020 (Subsequent Contract Term)**, subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of an amendment executed by the parties, authorize continued operations of the Contractor under the same contract prices for not more than one (1) additional twelve (12) months periods from July 1, 2020 – June 30, 2021. ("Subsequent Contract Term").


All other terms and conditions of the Main Agreement remain in effect.
