MEMORANDUM OF UNDERSTANDING
BETWEEN
OKALOOSA COUNTY EMERGENCY SERVICES
AND

This agreement is entered into by and between the **OKALOOSA COUNTY EMERGENCY SERVICES** and **FORT WALTON BEACH MEDICAL CENTER**, Fort Walton Beach, Florida and is effective October 28, 2003.

The initial licensure survey of the Destin Emergency Care Center, an outpatient department of the Fort Walton Beach Medical Center, located at 996 Airport Road, Destin, Florida, was conducted on October 28, 2003. This facility was found in compliance with the applicable requirements (H 0030 through H 0063) of 59A-3,F.A.C. and is designated as a free-standing emergency department.

The parties acknowledge and agree to the following:

1. The Okaloosa County Emergency Services will respond to requests made by the Destin Emergency Care Center as any emergency medicine department in the service area.
2. The Okaloosa County Emergency Services will transport from the Destin Emergency Care Center to Fort Walton Beach Medical Center or other local facility as requested by physician/patient.
3. For transports from the Destin Emergency Care Center to Fort Walton Beach Medical Center, the hospital agrees to pay Okaloosa County Emergency Services the current transport rate from the Destin Emergency Care Center to Fort Walton Beach Medical Center.


