This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 21-POL-R-293 ("Main Agreement") dated September 27, 2020 between Axon Enterprise, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. Replace Exhibit A, Scope of Services in its entirety with the attached Revised Exhibit A, Scope of Services.
- 2. Section 3, **CONTRACT AMOUNT**, is replaced in its entirety to include additional items added in accordance with Attachment A Axon Enterprise's Quote **Q-282396-44305.847CD**, as follows:

The County will pay the Contractor in accordance with the terms of the Payment section below in an amount that will not exceed \$3,726,736.00 during the Initial Term paid in annual installments as described in Exhibit C. Upon renewal for an additional one-year period, the County will pay the Contract in an amount that will not exceed \$640,200.00 during the Subsequent Contract Term. The Contractor will complete the Work for the total amount specified in this section ("Contract Amount").

Additional goods and services will be billed at the rates set forth in Sourcewell Contract 010720-AXN unless otherwise agreed by both parties in writing through fully executed amendment to this Contract.

All other terms and conditions of the Main Agreement remain in effect.

EXHIBIT A REVISED SCOPE OF WORK

1. Overview

Axon (Contractor) shall provide all hardware, software, support and training for a complete body-worn camera ("BWC") solution and In-car camera ("Fleet") solution for the Arlington County Police Department (County or ACPD) use as detailed in this Scope of Work and Exhibit C. In conjunction with the existing Interview Room cameras purchased under a separate contract, this additional hardware and services will give ACPD a unified platform for gathering, archival, and distribution of video evidence ("System").

2. Deliverables

2.1 Body-Worn Component

- 2.1.1 Contractor shall furnish the following hardware:
 - 600 (six hundred) Axon Body 3 BWCs for primary use
 - 10 (ten) Axon Body 3 BWCs to be used as spares
 - 38 (thirty-eight) **Axon Body 3** 8-bay charging/syncing docs
- 2.1.2 Each camera and dock will be covered by the following support and assurance plans:
 - Unlimited Plus TAP program.
 - Technology Assurance plan
 - Axon Full-Service Plan

Coverage provided the plans listed above are described in the Master Services and Purchasing Agreement, incorporated into Sourcewell Agreement 010720-AXN.

- 2.1.3 Contractor shall furnish the following access licenses the cloud-based storage ("Evidence.com"):
 - Pro-level license for 310 users, of those licenses 10 will have administrative privileges 12,000 GB of additional third-party data storage.
 - Basic-level license for 30 users
 - Redaction assistance license for 310 users

2.2 Fleet Component

- 2.2.1 Contractor shall furnish the following hardware:
 - 320 Axon Fleet 2 cameras (2 per vehicle)
 - 320 Axon Fleet 2 Battery Boxes (2 per vehicle)
 - 160 Axon Signal Units
 - 160 Cradlepoint IBR900-1200 router
 - Antenna unit
 - All wiring, brackets, and hardware required for integration of the the devices listed above
- 2.2.2 Installation and configuration:

Axon will be performing the installation of all Axon Fleet vehicle hardware. Installation

services purchased from Axon include a "clip" and removal of existing in-car system hardware. This does not include "full removal" of existing wiring. While initially Contractor will install **Axon Fleet 2** cameras, Contractor shall update the Fleet hardware to **Axon Fleet 3** model at no additional cost upon the release of Fleet 3, tentatively in Q2-Q3 2021, in accordance with Quote.

- 2.2.3 Each Fleet camera system component will be covered by the following support and assurance plans:
 - Technology Assurance plan.
 - Axon Full-Service Plan.

Coverage provided the plans listed above are described in the Master Services and Purchasing Agreement, incorporated into Sourcewell Agreement 010720-AXN.

- 2.2.4 Contractor shall furnish the following licenses:
 - Fleet 2 View XL vehicle license.
 - Fleet Evidence.com storage, unlimited.

3. Delivery and Acceptance

Contractor shall deliver all hardware FOB Arlington, VA. All shipping costs shall be included in the unit prices.

County Project Officer or Designee will inspect the delivery within 10 calendar days from the date of receipt and determine acceptance.

4. Project Schedule

Provided this Agreement is fully executed by September 30, 2020, Contractor shall meet the following tentative milestones as counted from the Effective Date of the Agreement:

• Delivery of Year 1 hardware complete: on or before December 15, 2020; early delivery dependent on Agency-selected training dates.

- Training, installation, and commissioning to be scheduled between Axon and Agency, and shall be completed no later than 30 (thirty) days from the date of equipment delivery for the BWC component, and 60 (sixty) days from equipment delivery for Fleet component, subject to County Staff availability and County policy approval.
- Testing to ensure proper install will be completed at the time of installation.

5. Contractor Roles and Key Personnel

Contractor shall assign two project managers that will provide the expertise to execute a successful deployment and implementation. One project manager will be responsible for the BWC side of the Scope (Axon Full Service), and the other project manager will be responsible for the Fleet Side (Standard Fleet Installation). Project managers will have knowledge and experience with all phases of the project management lifecycle and with all application modules being implemented. Contractor will also assign a Customer Success Manager to support the account over the life of the Contract. This Key Personnel will work closely with the County Project Officer and project team members and will be responsible for completing the tasks required to meet all contractual obligations.

6. County Responsibilities

- 6.1 County will assign a Project Officer to coordinate the County staff and resources involved in the implementation of the program.
- 6.2 County will provide the following hardware for the Fleet program:
 - Mobile Data Terminal
 - 4G mobile internet data connection without data throttling or data cap
 - Indoor parking space for installation of the fleet equipment
