AGREEMENT NO. 22-DES-ITBLW-473  
AMENDMENT NUMBER 1**

This Amendment No. 1 ("Amendment") is made on April 16, 2022, by the County and amends Agreement Number 22-DES-ITBLW-473 dated April 8, 2022 ("Main Agreement") between ReeSource Pest, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

**1. Exhibit F – Contract Pricing** is hereby changed to add the following locations:

**a. Section "B" List Professional Office Building Treatment, DHS:**

d. **Section “D” List: Other Pest Services Requested By The County is hereby changed to add:**

- **BurrowRx Treatment at a cost of \$195.00 per hour.**

2. Exhibit F – Contract Pricing is hereby deleted in its entirety and replaced with the attached **Revised Exhibit F – Contract Pricing**. Pricing from **April 15, 2022, to April 30, 2023**, shall be in accordance with **Exhibit F – Contract Pricing**. The Contract amount is hereby changed from **\$50,400.00** to **\$82,656.00**, an increase by **\$32,256.00**.

All other terms and conditions of the Main Agreement remain in effect.
