**AGREEMENT NO. 18-227-ITB-1
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on January 7, 2022, and amends Agreement Number 18-227-ITB-1 (“Main Agreement”) dated January 7, 2019, between Jones Utilities Construction, Inc. (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. **Contract Renewal:** Per clause 4. Contract Term, this Contract is hereby renewed for its first subsequent contract term beginning January 7, 2022 through January 6, 2023.
2. **Contract Price Increase:** Pursuant to Section 6. Contract Price Adjustment (as amended below), the contract is hereby increased by 1.051 percent change per the U.S. Department of Labor Producer Price Index for Industry: “Electrical contractors, nonresidential building work” (“NAICS-based PPI Code: 23821X – Series ID PCU23821X23821X”) for the 12-month period ending in September 2021 using the Simple Percentage Method as described in the [Price Adjustment Guide for Contracting Parties](#).

Attachment F – Price Bid of Contractor is hereby deleted in its entirety and replaced with the attached **Exhibit F – Price Bid of Contractor**. Pricing from January 7, 2022, to January 6, 2023, shall be in accordance with **Exhibit F – Price Bid of Contractor**. The Contract amount is hereby changed for Non-Emergency Category I from **\$1,664,292.75** to **\$1,748,637.66**, an increase of **\$84,344.91**.

3. **Contract Pricing With Optional Price Adjustments** is hereby deleted in its entirety and changed to read:

6. CONTRACT PRICING WITH OPTIONAL PRICE ADJUSTMENTS

The Contract Amount/unit price(s) will remain firm until the end of Initial Contract Term (“Price Adjustment Date”). To request a price adjustment, the Contractor or the County must submit a written request to the other party not less than 90 days before the Price Adjustment Date. Adjustments to the Contract Amount/unit price(s) will not exceed the percentage of change in the U.S. Department of Labor Producer Price Index for Industry: “Electrical contractors, nonresidential building work” (“NAICS-based PPI Code: 23821X – Series ID PCU23821X23821X”) for the 12-month period ending in September 2021. Adjustments shall be made using the Simple Percentage Method as described in the [Price Adjustment Guide for Contracting Parties](#).

Any Contract Amount/unit price(s) that result from this provision will become effective the day after the Price Adjustment Date and will be binding for 12 months. The new Price Adjustment Date will be 12 months after the price adjustment.

If the Contractor and the County have not agreed on a requested adjustment by 30 days before the Price Adjustment Date, the County may not renew the Contract, whether or not the County has previously elected to renew the Contract's term.

4. **Payment Terms** is hereby deleted in its entirety and changed to read:

8. PAYMENT TERMS

The Contractor must submit invoices to the County's Project Officer, who will either approve the invoice or require corrections. The County will pay the Contractor 45 days after approval of an invoice for completed work which is reasonable and allocable to the Contract. The number of the County Purchase Order pursuant to work has been performed must appear on all invoices.

5. **Audit** is hereby deleted in its entirety and changed to read:

35. AUDIT

The Contractor must retain all books, records and other documents related to this Contract for at least five years, or such period of time required by the County's funding partner(s), if any, whichever is greater, after the final payment and must allow the County or its authorized agents to examine the documents during this period and during the Contract Term. The Contractor must provide any requested documents to the County for examination within 15 days of the request, at the Contractor's expense. Should the County's examination reveal any overcharging by the Contractor, the Contractor must, within 30 days of County's request, reimburse the County for the overcharges and for the reasonable costs of the County's examination, including, but not limited to, the services of external audit firm and attorney's fees; or the County may deduct the overcharges and examination costs from any amount that the County owes to the Contractor. If the Contractor wishes to destroy or dispose of any records related to this Contract (including confidential records to which the County does not have ready access) within five years after the final payment, or such period of time required by the County's funding partner(s), if any, whichever is greater, the Contractor must give the County at least 30 days' notice and must not dispose of the documents if the County objects.

The Purchasing Agent may require the Contractor to demonstrate that it has the necessary facilities, ability, and financial resources to comply with the Contract and furnish the service, material or goods specified herein in a satisfactory manner at any time during the term of this Contract.

6. **Notices** is hereby deleted in its entirety and changed to read:

46. NOTICES

Unless otherwise provided in writing, all legal notices and other communications required by this Contract are deemed to have been given when either (a) delivered in person; (b) delivered by an agent, such as a delivery service; or (c) deposited in the United States mail, postage prepaid, certified or registered and addressed as follows:

7. **Incorporation of Sexual Harassment Policy** is hereby added to the Contract Terms and Conditions.

54. SEXUAL HARRASSMENT POLICY

If the Contractor employs more than five employees, the Contractor shall (i) provide annual training on the Contractor's sexual harassment policy to all supervisors and employees providing services in the Commonwealth, except such supervisors or employees that are required to complete sexual harassment training provided by the Department of Human Resource Management, and (ii) post the Contractor's sexual harassment policy in (a) a conspicuous public place in each building located in the Commonwealth that the Contractor owns or leases for business purposes and (b) the Contractor's employee handbook.

8. **Incorporation of COVID-19 Vaccination Policy For Contractors** is hereby added to the Contract Terms and Conditions.

55. COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including

policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County’s workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, must be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

9. **Incorporation of Material Changes** is hereby added to the Contract Terms and Conditions.

55. MATERIAL CHANGES

The Contractor shall notify Purchasing Agent within seven days of any material changes in its operation that relate to any matter attested regarding certifications on its bid form.

All other terms and conditions of the Main Agreement remain in effect.
