AMENDMENT NO. 1 TO CONTRACT 19051 POND MAINTENANCE

The City of Daytona Beach, a Florida municipal corporation (the "City") and Clear Waters, Inc., a Florida profit corporation ("Contractor"), hereby agree to amend Contract 19051 (the "Contract"), approved by City Commission Resolution No. 18-417, as follows:

SECTION 1 Section 3 (b) of the Contract is hereby amended as follows:

Section 3. Compensation and Payments; Limitations]

(b) Subject to the provisions of Subsection 3(c), the CITY will pay CONTRACTOR \$40,200 \$44,050.00 for the services to be performed, at the rates of \$1,675 monthly. This pricing is based provided on the Price Schedule attached hereto and incorporated herein as Exhibit B.1.

SECTION 2 Exhibit A of the Contract, Scope of Services, is amended to read as follows:

- I. c. The Contractor will provide the services outlined below on a monthly basis for each lake (pond) <u>unless otherwise specified</u>. All visits will be scheduled for optimum estimated effectiveness.
 - I. n. Make at **minimum** one visit per month per site, <u>unless otherwise specified.</u>

SECTION 3 Exhibit A, Scope of Services, is amended to include Attachment A illustrating the location of the 3 ponds added by this amendment.

II. MONTHLY SCHEDULED SERVICES

- II. a. Contractor will monitor water conditions in specified areas and provide weed control services consistent with the Scope of Work and good aquatic management services monthly for locations 1 through 20 described in Exhibit B.1. Location 21 will be serviced as needed. Location 22 will be serviced quarterly, i.e., once every 3 months.
- II. c. The Contractor will complete a minimum of one monthly pond maintenance inspection checklist per pond site (Attachment 1) for those locations requiring monthly service. For ponds receiving less than monthly service, the Contractor will complete one pond maintenance inspection checklist for each pond, on each occasion that service is provided.
