**FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA
COUNTY, FLORIDA AND
RENTOKIL DBA FLORIDA PEST CONTROL
CONTRACT NO. C20-2964-AP**

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and Rentokil dba Florida Pest Control (the "Contractor"), executed this 27th day of July, 2022, is made a part of the original Agreement dated October 1, 2020, Contract No. C20-2964-AP (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **OPTION TO RENEW.** The parties hereby wish to exercise their option to renew the original Agreement for an additional one (1) year term in accordance with Section III of the original Agreement.
2. **EFFECTIVE DATE OF RENEWAL TERM.** The Effective Date of this Amendment shall commence October 1, 2022 and shall terminate no later than September 30, 2023.
3. **AMENDED.** The County and Contractor wish to amend the original Agreement to add the following location as part of the service area, there will be no additional charge for this location:

Concourse C of the Terminal Building.
4. **COMPENSATION.** Compensation for this renewal term of the Agreement shall:

Stay the same as set forth in Section IV of the original Agreement ("Compensation") and/or any amendments thereto; or
5. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated October 1, 2020 and any amendments thereto, shall remain in full force and effect.
6. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
