**FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the state of Florida (the "County"), and Pump & Process Equipment, Inc., executed this 10 day of February, 2022, is made a part of the original Agreement dated January 3, 2022, Contract No. C22-3148-WS (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. The parties wish to amend Section 4 of the original Agreement as follows: The Contractor agrees to provide the Services to the County, including materials and labor, for one hundred seventy dollars (\$170.00) per unit that is monitored. Currently there are ninety-nine (99) units being monitored for a total of sixteen thousand, eight hundred thirty dollars (\$16,830.00). However, the total amount may be increased or decreased depending on the number of units being monitored by the Contractor. ~~in a total amount of sixteen thousand, four hundred ninety Dollars (\$16,490.00).~~
2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated January 3, 2022 and any amendments thereto, shall remain in full force and effect.
3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.

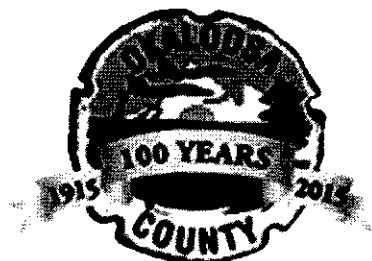
