**AGREEMENT NO. 18-260-ITB-LW-2
AMENDMENT NUMBER 3**

This Amendment Number 3 is made on June 17, 2022, and amends Agreement Number 18-260-ITB-LW-2 (“Main Agreement”) dated September 13, 2018, between **Sunny’s Coach Service, Inc. dba Sunny’s Worldwide Transportation** (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. Temporary Price Increase:** The contract amount is hereby increased temporarily by ten percent (10%) for bus services and up to ten percent (10%) for fuel surcharge beginning **June 17, 2022 through September 12, 2022. The fuel surcharge is only applicable when fuel is above \$4.00 per gallon.** The contract amount is hereby changed from \$39,800.00 to **\$43,780.00**, a \$3,980 increase through **September 12, 2022.**
- 2. Attachment A, Pricing Schedule** is hereby changed to **Attachment B, Contract Pricing.** All references to Attachment A, Pricing Schedule shall be referenced as **Attachment B, Contract Pricing.**
- 3. Temporarily replace Attachment B, Contract Pricing** in its entirety with the Attached Temporary **Attachment B, Contract Pricing** through **September 12, 2022. Attachment B, Contract Pricing shall revert back to the original pricing dated September 13, 2018.**

All other terms and conditions of the Main Agreement remain in effect.
