AMENDMENT NUMBER 3**

This Amendment Number **3** is made on 10/19/2022 by the County and amends Agreement Number **20-118-ITB** ("Main Agreement") dated January 10, 2020, between **Cedric J Whitaker dba EC Whitaker Enterprises** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

- 1. CONTRACT TERM:** Pursuant to Section 2. The contract is hereby renewed for contract term beginning **January 1, 2023, to December 31, 2024**, no renewals remaining.
- 2. CONTRACT PRICING WITH OPTIONAL PRICE ADJUSTMENTS:** Pursuant to Section 5.
