Interlocal Agreement

This Interlocal Agreement, made and entered into will become effective the 20th day of May, 2014, by and between the West Florida Regional Planning Council (hereinafter referred to as "WFRPC") and the County of Okaloosa (hereinafter referred to as "Okaloosa County" or "County"), which is a political subdivision of the State of Florida.

WITNESSETH:

WHEREAS, Section 163.01, Florida Statutes, permits local government units to make the efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, Section 186.501, Florida Statutes, mandates the creation of regional planning councils and recognizes them as Florida's only multipurpose regional entity that is in a position to plan for and coordinate intergovernmental solutions to growth-related problems on greater-than-local issues, provide technical assistance to local governments, and meet other needs of the communities in each region; and

WHEREAS, Okaloosa County has been a member of the WFRPC since May 9, 1974; and

WHEREAS, the purpose of this agreement is to foster cooperation between the County and the WFRPC regarding necessary technical assistance.

NOW, THEREFORE, Okaloosa County and the WFRPC agree as follows:

The purpose of this agreement is to foster cooperation and communication between the two parties and to provide a formal vehicle for provision of technical assistance by WFRPC to the County as needed, and when agreed upon in writing by both parties, per the Florida Statutes.

IN WITNESS WHEREOF, the County and WFRPC have officially adopted and caused this agreement to be executed and their signature to be affixed by their respective Chairman as of the day and year first above written.
